

CONCESSION ON VESSEL RELATED CHARGES FOR THE VESSELS CALLING AT CONTAINER TERMINAL AT KPL.

KPL is pleased to inform to the Trade that, the existing concession on Vessel related charges for the vessels calling at Container Terminal at KPL implemented vide Trade Notice No. 02/2019 dated 04.06.2019 is hereby extended till 31.03.2021.

The details of concession on Vessel related charges for Container vessels are given below.

1. Concession on Vessel related charges for Container vessels:

The concession on Vessel related charges from the amended Scale of Rates for Container vessels are given below.


- i. 15% concession in VRC for all Coastal Container vessels from 01.04.2020 to 31.03.2021.
- ii. Upfront concession in VRC to EXIM container vessels from 01.04.2020 to 31.03.2021 as tabulated below.

3. Loyalty Reward:

In addition to the above upfront concessions, additional benefit to those services that are loyal to KPL is offered. The container vessel services which make 30 to 49 calls from 01.04.2020 to 31.03.2021 shall be eligible for a loyalty discount @ 2% of the total VRC limited to Port Dues & Pilotage charges paid by them during the period specified (after discount) and shall be paid as Loyalty Reward at the end of the year. Further, for those services which make 50 or more calls from 01.04.2020 to 31.03.2021, 5% of the total VRC limited to Port Dues & Pilotage charges paid during the period specified (after discount) shall be given as Loyalty Reward at the end of the year. For calculation of the additional Loyalty Reward, the voyages done by the services from 01.04.2020 to 31.03.2021 shall be taken into account.

The Trade is hereby requested to widely communicate the contents of the Trade Notice among the trade members and everyone concerned.
